## **EXECUTIVE SESSION**

In accordance with Texas Government Code, Subchapter D:

### **(Litigation/Consultation with Attorney) Section 551.071**

HACA may seek advice from its attorney regarding a pending or contemplated litigation subject, settlement offer, or attorney-client privileged information. Litigation is, by its nature, an on-going process, and questions may arise as to a litigation tactic or settlement offer, which needs to be explained to the HACA. Upon occasion, the HACA may need information from the City Attorney as to the status of the pending or contemplated litigation subject, settlement offer, or attorney-client privileged information. After executive session discussion, any final action or vote taken, will be in public.

The following pending litigation subjects which may be discussed are:

Duke v. Housing Authority of the City of Abilene

### **(Personnel) Section 551.074**

HACA may consider appointment, employment, reassignment, duties, discipline, or dismissal of public officers or employees, Executive Director, Chief Financial Officer. After discussion of appointment and evaluation of HACA Appointees in executive session, any final action or vote taken will be in public.

### **(Real Property) Section 551.072**

HACA may consider the purchase, exchange, lease, or value of real property in a closed meeting when deliberation in an open meeting would have a detrimental effect on the position of the governmental body in negotiations with a third person.

### **(Business Prospect/Economic Development) Section 551.087**

HACA may discuss or deliberate on commercial or financial information that has been received from a business prospect that the HACA seeks to conduct economic development negotiations with or deliberate the offer of a financial or other incentive to a business prospect. After discussion of the contemplated economic development matters in executive session, any action or vote will be taken in public.
